Dear Major Faulkner:

I want to thank you for looking into Marla S. Ailion's (a/k/a Maria S. Wright) situation. As discussed, she is being held on an order which Judge Grubbs did not have jurisdiction to enter. Maria filed an Application for Appeal with the Court of Appeals on July 10, 2006 which was transferred to the Supreme Court of Georgia and docketed on July 19, 2006 where it is still pending. (A06D0397).

On July 17, 2006, Judge Grubbs entered an order granting Marla Ailion a supersedeas as to the June 8, 2006 order which was one of two orders appealed. Judge Grubbs' order further indicated that Ms. Wright was being held on an October 19, 2006 order which obviously does not exist. There is an October 19, 2004 order which states how much my wife owes Mr. Ailion and originally did incarcerate Ms. Wright, however, she was released from this ordered incarceration period on December 15, 2005. Ms. Wright was re-incarcerated on January 30, 2006. In two recent orders (June 12, 2006 and July 5, 2006), Judge Grubbs stated that Ms. Wright was being held on the June 8, 2006 order, it is Ms. Wright's understanding that the Judge cannot change these orders when an appeal has been filed in a case and a supersedeas has been granted.

Ms. Wright has a full time job waiting for her at Sentry Surveillance (770-592-0400). The Cobb County Sheriff's Office has been notified that there is a stay on the one order holding Ms. Wright in jail and that any further orders are unenforceable. Every day Marla has to stay in jail she is losing wages from Sentry Surveillance. Marla should be released immediately.

I am attaching the June 8, 2006, June 12, 2006, and July 5, 2006 orders as you have requested. Please contact me at 770-912-2807 should you need any additional information.
